## Special Provision(s)

1. Integrated Protected Areas Fund. In addition to the amounts appropriated herein, the following funding sources, constituted into the Integrated Protected Areas Fund (IPAF) shall be used to finance projects and activities of the National Integrated Protected Areas System (NIPAS) in accordance with Section 16 of R.A. No. 7586, as amended by R.A. No. 10629:

a) Thirty Million Pesos (P30,000,000) from the Twenty-Five percent (25%) income generated by each protected area from the operations of the NIPAS and management of wild flora and fauna, deposited with the National Treasury and released subject to the submission of a Special Budget pursuant to Section 35, Chapter 5, Book VI of E.O. No. 292, s. 1987; and

b) Seventy-Five percent (75%) income retained by each Protected Area Management Board (PAMB), deposited in an authorized government depository bank.

In no case shall said amount be used for payment of Personnel Services.

The DENR and each PAMB shall submit its quarterly reports on financial and physical accomplishments, including the list of projects and activities and their corresponding amounts, with electronic signature to the DBM, through the Unified Reporting System, and to the Speaker of the House of Representatives, the President of the Senate of the Philippines, the House Committee on Appropriations and the Senate Committee on Finance, by posting said reports on DENR website for a period of three (3) years. The Secretary of Environment and Natural Resources shall send written notice to the said offices when said reports have been posted on its website, which shall be considered the date of submission.

2. Wildlife Management Fund. In addition to the amounts appropriated herein, the amount of Five Million Five Hundred Thousand Pesos (P5,500,000) shall be used for the conservation and protection of wildlife resources sourced from fines, damages, fees, charges, donations, endowments, grants or contributions collected or granted within the jurisdiction of the DENR, constituted into the Wildlife Management Fund in accordance with Sections 4 and 29 of R.A. No. 9147.

Release of funds shall be subject to the submission of a Special Budget pursuant to Section 35, Chapter 5, Book VI of E.O. No. 292, s.1987.

The DENR shall submit its quarterly reports on financial and physical accomplishments, including the list of projects and activities with their corresponding amounts, with electronic signature to the DBM, through the Unified Reporting System, and to the Speaker of the House of Representatives, the President of the Senate of the Philippines, the House Committee on Appropriations and the Senate Committee on Finance, by posting said reports on DENR website for a period of three (3) years. The Secretary of

Environment and Natural Resources shall send written notice to the said offices when said reports have been posted on its website, which shall be considered the date of submission.

3. **Comprehensive Agrarian Reform Program.** The amounts of Ninety One Million Eight Hundred Ninety-Five Thousand Pesos (P91,895,000) and One Hundred Sixty Eight Million Nine Hundred Fifty Seven Thousand Pesos (P168,957,000) appropriated herein shall be used exclusively in support of the Land Survey and Distribution and Program Beneficiaries Development, respectively, under the Comprehensive Agrarian Reform Program.

4. **Operational Plan for the Manila Bay Coastal Management Strategy.** Of the amounts appropriated herein, Eighty Million Pesos (P80,000,000) shall be used for the implementation of the Operational Plan for the Manila Bay Coastal Management Strategy pursuant to the Supreme Court Decision in Metropolitan Manila Development Authority, et. al., vs. Concerned Citizens of Manila Bay, G.R. No. 171947-48 promulgated on December 18, 2008.

Release of funds shall be subject to the submission by the DENR to the DBM of its detailed program of work.

5. **National Greening Program.** The amount of Two Billion One Hundred Forty Four Million Eight Hundred Forty Six Thousand Pesos (P2,144,846,000) appropriated herein under Forest Development, Rehabilitation, Maintenance and Protection shall be used for the following National Greening Program purposes with their corresponding amounts:

a) Two Billion Twenty Million Six Hundred Twenty Six Thousand Pesos (P2,020,626,000) for site maintenance and protection covering prior years' planting activities and site preparation and mobilization for the current year's planting activities. Release of funds shall be subject to the submission to the DBM, either in printed form or by way of electronic document, of a report on the status of accomplishment of the FY 2017 target planting activities as of September 30, 2017 including geo-tagged photos taken at a spatial resolution of 2-4 cm per pixel with time stamp; and

b) One Hundred Twenty Four Million Two Hundred Twenty Thousand Pesos (P124,220,000) for seedling or planting activities and site maintenance and protection covering current year's planting activities: PROVIDED, That, the amount of Fifty Million Pesos (P50,000,000) shall be earmarked for the planting activities and site maintenance and protection of nipa palm trees, including mangrove reforestation for the coastal campuses of state universities and colleges. Release of funds shall be subject to the submission to the DBM, either in printed form or by way of electronic document, of the FY 2018 identified sites for target planting activities, including geo-tagged photos taken at a spatial resolution of 2-4 cm per pixel with time stamp.

The DENR shall submit reports on the status of accomplishment of the NGP from 2011-2018, including the geo-tagged photos of the sites and the impact of the program to the communities, with electronic signature to the DBM, through the Unified Reporting System, and to the Speaker of the House of Representatives, the President of the Senate of the Philippines, the House Committee on Appropriations and the Senate Committee on Finance, by posting said reports on DENR website for a period of three (3) years. The Secretary of Environment and Natural Resources shall send written notice to the said offices when said reports have been posted on its website, which shall be considered the date of submission.

6. **Foreshore Mapping and Master Planning Activities.** In support of the aim of the Fisheries Code of the Philippines to establish fisherfolk settlements and to provide for secure tenurial arrangements that support resource stewardship, provide space for non-catch and non-marine livelihoods and tenure for housing, the DENR shall implement its foreshore mapping and master planning activities in a manner that:

- (i) Assists LGUs in incorporating fisherfolk settlements into their Comprehensive Land Use Plans (CLUPs);
- (ii) Uses the roster of actually-existing settlements based on the BFAR Fisherfolk Registry (FISH-R); and

(iii) Prioritizes identification of settlements for those with the most numerous fisherfolk, those most exposed to floods and surges, as well as those that are critical cooperators in efforts to conserve and restore coastal resources and marine stocks.

The DENR shall include in its one map program those coastal areas jointly nominated by BFAR in consultation with fisherfolk organizations for delineation and formalization in LGU CLUPs as settlements. In the interim, between BFAR's nomination of an area as a fisherfolks settlement and its inclusion as such into the LGUs CLUP, if determined to be within legal bounds and in the safe zone, the DENR shall prioritize the process of delineating and establishing the fisherfolk settlement over competing applications for tenure, in accordance with the Fisheries Code.

Whenever applicable and as resources permit, the DENR Central Office and its field offices and bureaus shall have work plans and target outputs for pilot areas for fisherfolks seeking to collectively establish their settlements in cooperation with BFAR and their LGUs. The relevant offices identified by the DENR Secretary shall:

(1) Secure from BFAR the list of fisherfolk settlements that would benefit from the pilot. DENR would then cause the issuance of tenurial instruments such as residential free patents for alienable and disposable agricultural areas, Community-Based Forestry Management Agreements (CBFMA), Protected Area Community-Based Resource Management Agreements (PCBRMA), Foreshore Lease Agreements (FLA) as well as applicable tenure arrangements where fishpond lease agreements have already expired to qualified applicants; and

(ii) Develop new class tenurial instruments, possibly to be jointly administered with BFAR or co-managed with the LGU, for parcels that are to become part of delineated fisherfolk settlements with support from the Land Management Bureau; the DENR, the LGUs or the fisherfolk organizations shall make certain that such tenurial instruments shall ensure that activities and investments are geared towards appropriate technologies to prevent the direct discharge of untreated sewage into bodies of water and to ensure that fisherfolk will contribute to the overall stewardship of coastal and marine resources.

7. **Establishment of Arboretum.** The Biodiversity Management Bureau (BMB) of the DENR shall establish an arboretum of native, endemic and indigenous tree and plant species, including medicinal plants, at the Ninoy Aquino Parks and Wildlife Center.

8. **Technical Assistance to State Universities and Colleges.** The DENR shall provide the necessary technical assistance to State Universities and Colleges in the protection, management and development of protected areas located within the campuses and in

the mapping and inventory of biodiversity of the province where the main campus of the SUC is located.

9. Appropriations for Programs and Specific Activities. The amounts appropriated herein for the programs of the agency shall be used specifically for the following activities in the indicated amounts and conditions:

## Special Provision(s)

1. **Air Quality Management Fund.** In addition to the amounts appropriated herein, Thirty Five Million Pesos (P35,000,000) shall be used to finance air pollution rehabilitation, research, enforcement, monitoring, and technical assistance activities sourced from the fines imposed and damages awarded to the Republic of the Philippines by the Pollution Adjudication Board, proceeds of licenses and permits issued, emission fees, donations, endowments and contributions, constituted into the Air Quality Management Fund in accordance with Section 14 of R.A. No. 8749.

Releases of funds shall be subject to the submission of a Special Budget pursuant to Section 35, Chapter 5, Book VI of E.O. No. 292.

The Environmental Management Bureau (EMB) shall submit its quarterly reports on financial and physical accomplishments, including the list of activities and their corresponding amounts, with signature to the DBM, through the Unified Reporting System, and to the Speaker of the House of Representatives, the President of the Senate of the Philippines, the House Committee on Appropriations and the Senate Committee on Finance, by posting said reports on EMB website for the period of three (3) years. The Director of EMB shall send written notice to the said offices when said reports have been posted on its website, which shall be considered the date of submission.

**Special Provision(s)**

1. **Income from Royalties.** In addition to the amounts appropriated herein, Twenty Three Million One Hundred Seventy Thousand Pesos (P23,170,000) and Forty Two Million Eight Hundred Thirty Thousand Pesos (P42,830,000) shall be used for the MOOE and Capital Outlay requirements, respectively, of the Mines and Geo-Sciences Bureau (MGB) sourced from ten percent (10%) of royalties derived from the development and utilization of mineral resources within reservations in accordance with Section 5 of R.A. No. 7942.

Release of funds shall be subject to the submission of a Special Budget pursuant to Section 35, Chapter 5, Book VI of E.O. No. 292.

The MGB shall submit quarterly reports on the financial and physical accomplishments, including the list of projects and activities and their corresponding amounts, with electronic signature to the DBN, through the Unified Reporting System, and to the Speaker of the House of Representatives, the President of the Senate of the Philippines, the House Committee on Appropriations and the Senate Committee on Finance, by posting said reports on MGB website for a period of three (3) years. The Director of MGD shall send written notice to the said offices when said reports have been posted on its website, which shall be considered the date of submission.
