DECLARATION OF ELIGIBLE AND SHORTLISTED BIDDERS

**Procurement of I.T. Consulting Firm for the Development of Caves and Wetlands
Information System (CWIS)**

WHEREAS, the Biodiversity Management Bureau approved the procurement of the above consulting services with an Approved Budget for the Contract (ABC) in the amount of Four Million Four Hundred Thousand Pesos (PhP4,400,000.00) inclusive of all applicable taxes and fees, to commence upon receipt of the Notice to Proceed (NTP);

WHEREAS, on 08 June 2021, the Bids and Awards Committee (BAC) advertised the Request for Expression of Interest (REI) for the said consulting services in the BMB Website, PhilGEPS Website and Bulletin Board;

WHEREAS, the procurement of the said services shall be undertaken through competitive bidding using Quality Based Evaluation (QBE) procedure with 70% minimum score to be shortlisted;

WHEREAS, in response to the said advertisement, the following firms submitted their accomplished eligibility documents before the deadline of submission on 21 June 2021, 1:00 PM:

- a. Tiaxa Philippines, Inc.
- b. My BusyBee Inc.

WHEREAS, On the same day, at 1:30 PM, the BAC opened the accomplished eligibility documents of the two (2) proponents and both of them passed the Eligibility Screening based on the non-discretionary "pass/fail" criterion;

WHEREAS, based on the qualifications required under the Terms of Reference (TOR) for shortlisting evaluation, Tiaxa Phils, Inc. and My BusyBee Inc. have complied with the requirements;

WHEREAS, the results of evaluation based on the submitted Eligibility Proposals are as follows:

WHEREAS, based on the approved detailed evaluation criteria, all proponents garnered a total score above the required minimum score of 70%;

NOW, THEREFORE, We, the members of the Bids and Awards Committee, hereby **RESOLVED**, as it is hereby **RESOLVED**:

1. To declare as Shortlisted and Eligible to proceed to the next stage of bidding activities the following proponents:
 - a. Tiaxa Philippines, Inc.
 - b. My BusyBee Inc.
2. To issue Notice of Eligibility to the said proponents inviting them to bid for the Consulting Services (Firm) for the Development of Caves and Wetlands Information System (CWIS); and
3. To recommend foregoing findings to the Head of Procuring Entity (HoPE) for approval.


