TERMS OF REFERENCE

The Biodiversity Management Bureau of the Department of Environment and Natural Resources (BMB – DENR) intends to engage the services of an individual as Legal Consultant for the amendment of Republic Act No. 9072 "National Caves and Cave Resources Management and Protection Act" and DENR Administrative Order No. 2003-29 "Implementing Rules and Regulations of RA 9072"

I. Background and Objectives

Republic Act No. 9072 "National Caves and Cave Resources Management and Protection Act" and its Implementing Rules and Regulations (DENR Administrative Order No. 2003-29) have been implemented for two (2) decades. Within this time span, several issues have arisen which the existing policies have not been able to address. Recent issues which are not yet covered by the law include management of underwater caves, cave water extraction, unclear regulations on cave exploration and on authorizing public disclosure of information on caves, among others.

To address the emerging issues and threats to cave management, protection and conservation, as well as to strengthen legal bases for the protection and management of caves and cave resources, this project aims to enhance existing cave laws through amendment. In order to do so, the legal expertise of a Legal Consultant is needed to determine gaps through policy analysis. A draft policy will be formulated by the Legal Consultant which will address policy gaps and harmonize existing policies related to cave and cave resources. In addition, this would require a level of expertise and attention beyond the optimum in-house capability of the Biodiversity Management Bureau and is consistent with the Government's policy not to compete with the private sectors in accordance with Item No. 2 of Annex B of Implementing Rules and Regulations of Republic Act No. 9184 "Government Procurement Reform Act".

- II. Service Description: Legal Consultant
- III. **Duration**: 8 months
- IV. Approved Budget: P450,000 (inclusive of taxes)

V. Qualification Requirements

The candidate must possess the following:

- Lawyer with background on environmental law particularly in biodiversity, NIPAS, wetland and caves;
- Have at least five (5) years of experience working with government, non-government organizations or professional organizations involved in the environmental and natural resource sector.
- Must have engagements on policy formulation related to biodiversity preferably on caves and wetlands

VI. Major Responsibilities (Scope of Work)

- Review policies related to cave management and conservation;
- Identify policy gaps on existing policies;
- Provide inputs and recommendation to enhance the effectiveness of policies related to the management and conservation of caves and cave resources;
- Draft policies for the amendment of the DAO 2003-29 and RA 9072;
- Participate in the meetings/consultations/workshops relevant for the drafting and presentation of the draft policies;
- Present the draft policies on relevant meetings and workshops e.g. BMB-TRC and PTWG;

- Assist in the review of other wetland related policies;
- Submit draft policies with possible revisions from inputs and recommendations during meetings/consultations/workshops.

VII. Implementation Arrangements

The Legal Consultant shall closely coordinate work progress with the Caves, Wetlands and Other Ecosystems Division of BMB and execute deliverables within mutually-agreed timeline.
