TERMS OF REFERENCE

PROCUREMENT OF SERVICES OF EXPERT IN SCUBA DIVING REFRESHER COURSE WITH COVID-19 SAFETY PROTOCOLS

The Biodiversity Management Bureau (BMB) of the Department of Environment and Natural Resources (DENR) intends to engage the services of Experts on Diving with COVID-19 Safety Protocols for the Capacity Building component of the Coastal and Marine Ecosystems Management Program (CMEMP).

I. PROJECT BACKGROUND AND RATIONALE

The DENR is mandated among others, to enhance the contribution of natural resources for achieving national economic and social development and conserve specific terrestrial and marine areas representative of the Philippine natural and cultural heritage for present and future generations. One of its staff bureaus, the BMB is tasked with establishing and managing protected areas; conserving wildlife; managing coastal biodiversity and wetlands ecosystems; and implementing information and education programs on biodiversity and nature conservation.

BMB has several Divisions including the Coastal and Marine Division (CMD) which formulate policies, guidelines, plans, programs and develop standards and benchmarks for the management of coastal and marine areas under NIPAS and LGU-managed protected areas; monitor and evaluate the implementation of policies, guidelines, plans and programs on coastal and marine ecosystems management; update and maintain database and information system on coastal and marine biodiversity, including socio-economic profile of coastal communities; and identify gaps on the management of coastal and marine ecosystems.

The CMD trains and deploys SCUBA divers to conduct research including assessments and monitoring of coastal and marine ecosystems in the country. Unfortunately, similar to other research and scientific institutions all around the world, the CMD has suspended field research leaving many of these divers' work in limbo.

While it is anticipated that the imposed quarantine may be lifted in the near future, some divers may be too fearful to ever come back to diving. The majority of existing divers are likely to return slowly as they gather information and assess the risk. Those divers who are concerned are looking for answers to confidently return to safe diving. Education and a growing awareness to these divers can help to reduce the spread of Covid-19 and accelerate their return.

The proposed training course will cover topics that are simple, realistic, accurate, and follow the science. It is designed to have the depth and breadth of information across the diving industry that can reach the masses of divers and non-divers as well.

II. OBJECTIVE, SCOPE AND COVERAGE

The training course is designed to enable participants to acquire an awareness and understanding of prescribed protocols and procedures for COVID 19 safe diving and apply them in actual diving operations to help to reduce the spread of Covid-19 and accelerate their return to diving.

- Present to the trainees the current recommendations on risk prevention and mitigation procedures for diving
- To provide trainees information and practical applications on the following:
 - o Measures that should be taken for the safety of divers and diving staff
 - Proper rinsing and disinfection of equipment
 - o Protective measures that should be taken on diving boats
 - Buddy checks and gas sharing safety procedures
 - Managing the safety of cylinder refills
 - o Proper actions to take during an emergency (First Aid and CPR)
 - o Information on the survival of the virus in sea water
 - Operating procedures and emergency action plan that may apply during this pandemic

III. EXPECTED OUTPUT

- Classrooms Lectures and Slide Presentations on Diving Safety Measures, Disinfection Operations, First aid and CPR, Survival of Viruses in Water, and Operating procedures and emergency action planning during a pandemic.
- On-Land Workshops on Diving Gear Assembly, Donning and Removing, Transporting, Stowage, and Marking
- 3. In-Water Workshops on Underwater Communication, Buddy Assistance, Distancing, Wind Direction Assessment, and Underwater Emergency Procedures
- 4. Refresher Course on Equalization, Buoyancy, Hovering, and other Basic skills with Actual Applications of COVID-19 Safety Protocols

IV. QUALIFICATIONS

The candidate for the Procurement of Services of Expert in Scuba Diving Refresher Course with Covid-19 Safety Protocols must have the following qualification:

- Licensed SCUBA Diving Instructor for at least three (3) years (preferably PADI);
- Has at least two (2) years of professional experience in Basic and Advance open water diving, First-Aid and Emergency Response, Provided orientation on COVID-19 Safety Protocols during Diving Activity;
- Should have provided technical training, licensing, facilitated SUBA Diving related capacity building activities for government and non-government employee for at least five (5) years; and

 has experience on conceptualizing capacity building activity designs related to SCUBA Diving and/or Specialized Diving
