**RESOLUTION NO. 2020-106**

**WHEREAS**, the Biodiversity Management Bureau posted a requirement for the **Supply and Delivery of 480 pcs of Cotton and Honeycomb T-Shirts with Embroidered Design** in the Philippine Government Electronic Procurement System (Phil-GEPS) with an Approved Budget for the Contract (ABC) of **P216,000.00**;

**WHEREAS**, nine (9) interested bidders submitted proposals/quotations as follows;

**WHEREAS**, the proposal of **MORIAH APPAREL HO, INC.** was not accepted because the sample shirt and embroidery material provided by the bidder did not meet the preferred qualities of the end-user in terms of fabric texture, appearance, and skewness;


**WHEREAS**, the proposal of **PRIMEWAVE ENTERPRISES, INC.** was not accepted because the bidder did not provide sample materials for the evaluation of the end-user;

**WHEREAS**, upon careful evaluation of the bids and upon recommendation of the end-user, the proposal of **BLUE CHIP MARKETING** was found to be the lowest calculated and responsive quotation since the same submitted samples that met the expectations of the end-user in terms of fabric quality, brand, collar fit, and quality of embroidery;

**NOW, THEREFORE**, We, the members of the Bids and Awards Committee, hereby **RESOLVED**, as it is hereby **RESOLVED**:


1. To award the contract to **BLUE CHIP MARKETING** as the Lowest Calculated and Responsive Quotation with a contract amount of **P167,520.00**;




