**WHEREAS**, four (4) interested bidders submitted proposals/quotations as follows;





**NOW, THEREFORE**, We, the members of the Bids and Awards Committee, hereby **RESOLVED**, as it is hereby **RESOLVED**:


1. To award the contract to PSW SPORTSWEAR TAILORING as the Lowest Calculated and Responsive Quotation with a contract amount of P79,040.00;


