WHEREAS, eight (8) interested bidders submitted proposals/quotations as follows;






NOW, THEREFORE, We, the members of the Bids and Awards Committee, hereby RESOLVED, as it is hereby RESOLVED:


1. To award the contract to PAPERPIX ENTERPRISE as the Lowest Calculated and Responsive Quotation with a contract amount of P156,000.00;
2. To recommend for approval by the Director of the Biodiversity Management Bureau the foregoing findings.




