WHEREAS, four (4) interested bidders submitted proposals/quotations as follows;





NOW, THEREFORE, We, the members of the Bids and Awards Committee, hereby RESOLVED, as it is hereby RESOLVED:





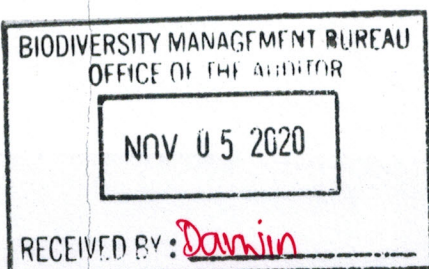
