BAC RESOLUTION AND RECOMMENDING APPROVAL RESOLUTION NO. 2020-156

WHEREAS, the Biodiversity Management Bureau (BMB) posted an Invitation to Bid for the bidding of "Printing, Supply and Delivery of NOAA Sets of Manual" in the Philippine Government Electronic Procurement System (Phil-GEPS), BMB Website and Bulletin Board with an Approved Budget for the Contract of Php3,802,000.00;

WHEREAS, after the deadline for submission and receipt of bids, two (2) bidders submitted bid proposals, as follows:

1. Dolmar Press, Inc. – P2,315,000.00

2. VJ Graphic Arts, Incorporated

WHEREAS, in the opening of bids conducted last December 7, 2020, VJ Graphic, Arts, Incorporated was rated "failed" for Registration;

WHEREAS, VJ Graphic Arts, Incorporated submitted a motion requesting for reconsideration of the failed submission, citing that their SEC Certificate number was listed in Annex "A" of PhilGEPS Certificate;

WHEREAS, the bid proposal of VJ Graphic Arts, Inc. was reconsidered despite the absence of a physical copy of a SEC Certificate on the ground that the bid document, upon opening of the bid envelope contained PhilGEPS Registration Certificate (Platinum Membership) and upon careful evaluation of the rules of bidding requirement, citing Section VIII of the 6th Edition of the Philippine Bidding Document for procurement of goods, potential bidders can submit either the PhilGEPS Registration Certificate or Class "A" Documents;

WHEREAS, after careful review by the BAC and its Technical Working Group, the bidder's request was found to be justified; hence, the request of VJ Graphic Arts, Inc. was granted;

WHEREAS, in the continuation of the opening of bids conducted on December 16, 2020, the bid proposal of VJ Graphic Arts, Incorporated was rated "passed," having submitted all the required documents with a bid amount of P2,061,000.00;

WHEREAS, after the bid evaluation and post qualification procedure, the BAC and its Technical Working Group found VJ Graphic Arts, Incorporated as the Lowest Calculated and Responsive Bidder;

NOW, THEREFORE, We, the members of the Bids and Awards Committee, hereby **RESOLVED**.



- 1. To declare the bid of **VJ GRAPHIC ARTS, INCORPORATED** as the Lowest Calculated and Responsive Bidder for the above mentioned requirement with a contract amount of **P2,061,000.00**; and
- 2. To recommend the foregoing findings for approval by the Director of the Biodiversity Management Bureau.

ARTICLE II - RESPONSIBILITIES OF BOTH PARTIES

RESPONSIBILITY OF BMB:

- 1. To provide the SUPPLIER the finalized soft copies of materials to be printed and approve sample work proof to mass production of materials; and
- 2. To pay the SUPPLIER the sum of TWO MILLION SIXTY ONE THOUSAND PESOS (Php2,061,000.00) upon completion of the project duly supported by documents as required under the existing accounting and auditing rules and regulations.

RESPONSIBILITY OF THE SUPPLIER:

- To undertake the job specified under Article I hereof in accordance with the specifications and all other requirements and condition as herein set; and
- 2. To provide sample of printed outputs before mass production of materials/manual.

ARTICLE III - EFFECTIVITY, LIQUIDATED DAMAGES, OTHERS

- 1. This Contract shall have a duration of Forty-five (45) Calendar Days to take effect upon approval of final proofing and receipt of the copy of the Notice to Proceed unless sooner rescinded or extended;
- 2. In case the SUPPLIER refuses or fails to satisfactorily deliver the items within the time specified herein, BMB shall deduct from the money due to the SUPPLIER Liquidated Damages computed in accordance with the formula provided for under RA 9184 and its IRR. The BMB need not prove that it had suffered actual damages;
- 3. The SUPPLIER shall hold BMB free from any liability or damages that may be inflicted to third persons or to the former employees and members in connection with the contract; and
- 4. Applicable provisions of the Civil Code on obligations and contracts are hereby adopted as part of this contract;

This Contract is subject to the provisions of R.A. 9184 and its Implementing Rules and Regulations.
