WHEREAS, five (5) interested bidders submitted proposals/quotations as follows;





NOW, THEREFORE, We, the members of the Bids and Awards Committee, hereby RESOLVED, as it is hereby RESOLVED:



2. To recommend for approval by the Director of the Biodiversity Management Bureau the foregoing findings.




