

NOW, THEREFORE, We, the members of the Bids and Awards Committee, hereby RESOLVED, as it is hereby RESOLVED:


1. To award the contract to JJKE TRADING being the Lowest Calculated and Responsive Quotation with a contract amount of P158,000.00;


