#### TERMS OF REFERENCE

### Procurement of Consultancy Firm for the Biodiversity-Friendly Enterprise (BDFE) and Business Development Services (BDS) of the ESBenePeat Project

The Biodiversity Management Bureau intends to engage the services of a consultancy firm for the Biodiversity-Friendly Enterprise (BDFE) and Business Development Services (BDS) of the ASEAN-EU-GIZ SUPA Component 1 Country Project entitled: "Ensuring Sustainable Benefits from Peatland through Protection and Wise Use" (ESBenePeat)

Description: Consulting Service to conduct Assessments of target

People's Organization and develop capacity development plan for Biodiversity-Friendly Enterprise (BDFE) and Business Development Services (BDS) of the ASEAN-EU-GIZ SUPA Component 1 Country Project entitled: "Ensuring Sustainable Benefits from Peatland through Protection and

Wise Use" (ESBenePeat).

**Duration of Contract:** 4 months

**Approved Budget:** Php 750,000 (inclusive of tax and travel expenses)

#### I. Background and Rationale:

The Department of Environment and Natural Resources (DENR) – Biodiversity Management Bureau (BMB), in its capacity as the National Focal agency for the ASEAN Task Force on Peatlands (ATFP), with the support from GIZ Deutsche Gesellschaft für Internationale Zusammenarbeit (GIZ) GmbH, is implementing the ASEAN-EU-GIZ Sustainable Use of Peatlands and Haze Mitigation (SUPA) country project entitled "Ensuring Sustainable Benefits from Peatland through Protection and Wise Use (ESBenePeat)". The project aims to ensure the sustained ecological functions and services of Philippine peatlands through its protection and sustainable management.

Among the work packages of the project, **Work Package 5** is on the Identification and Enhancement of Biodiversity Friendly-Practices for Peatland communities. This aims to generate income and open opportunities for the equitable sharing of benefits among stakeholders. The work package involves the conduct of a consultation workshop for the identification of existing and other potential livelihoods in degraded peatlands and enhancement training of the community's existing livelihoods for the two pilot sites. This work package also involves the identification of economic activities and practices of micro, small and medium enterprises, LGUs, and People's Organizations that promote the sustainable use of peatland.

In order to attain the objectives of this specific work package, capacity building, assessments, and workshops are needed as prerequisites for the effective implementation of the BDFE policies. Since BDFE is a relatively new concept, even though DENR staff may be capable and experienced in carrying out policies and programs related to environment and natural resources management, there is still a need for an expert.

#### II. Objectives and Scope of Works

The Work Package 5 (Identification and Enhancement of Biodiversity Friendly-Practices for Peatland communities) of the ESBEnePeat aims to capacitate the peatland-dependent community/ People's Organizations (POs) in improving their existing livelihood program with potential biodiversity-friendly practices and enterprises and for them to continuously develop their BDFEs. The output indicators of the said work package are trainings and workshops, therefore

requiring the implementers of said activities to be an expert on enterprise development for the communities.

The Project intends to engage the services of a consulting firm to(i) Conduct and submit reports of scoping and consultation workshops and (ii) Conduct and submit reports of trainings and workshops on Biodiversity-Friendly Enterprise (iii) develop a Capacity Needs Assessment (CNA) tool for BDFE,

The scope of work of this Terms of Reference is beyond the optimum in-house capability and current workload of the procuring entity and is consistent with the Government's policy not to compete with the private sector as integrated into Item 2 of Annex "B" of the 2016 Implementing Rules and Regulation of RA 9184.

#### III. Detailed Tasks

The consulting firm will work with the ESBenePeat Project Office and the OIC Chief of CAWED division of the Biodiversity Management Bureau, and will be responsible for the following tasks:

- 1. Conduct of scoping workshop in the two pilot sites (Leyte Sab-a and Agusan Marsh), to include the following:
  - Scoping Visit in the two-pilot site for identification of target People's Organizations (POs)
  - Capacity Assessment of the target People's Organizations (POs)
  - Rapid Assessment for the viability of existing livelihood
- 2. Conduct of two on-site workshops on Biodiversity-Friendly Enterprise and training on Business Development Services for each pilot sites, to include the following:
  - Policy Orientation and Skills Development
  - Consultation workshop for the identification of existing and other potential livelihoods in degraded peatlands.
  - Enhancement training on the existing community livelihood in Leyte Sab and Agusan Marsh
  - BDFE capacity development plan for PO Enterprises

#### IV. Duration

The Consultancy Firm shall be engaged continuously for a period of four (4) months effective upon signing of the contract and Notice to Proceed.

#### V. Deliverables and Reporting Arrangements

This is an output-based engagement. The Consultancy Firm will not be required to report regularly or be present at the Project Office during the contract period but will be requested to attend meetings and report to the OIC Chief of CAWED regarding progress as necessary. The Consultancy Firm shall work closely with DENR-BMB specifically with CAWED and the PMU of ESBenePeat Project for progress and updates on the consultancy assignment.

The firm is expected to submit the following deliverables:

- 1. Report on the Capacity Assessment of the target POs
- 2. Report on the Rapid Assessment for the inventory and viability of existing livelihood
- 3. Capacity Needs Assessment (CNA) tool for BDFE development
- 4. Report on the Conduct of a consultation workshop for the identification of existing and other potential livelihoods in degraded peatlands

- 5. Report on the conduct of enhancement training on the existing community livelihood in Agusan Marsh and Leyte Sab-a
- 6. BDFE capacity development plan for PO enterprises
