#### TERMS OF REFERENCE

### Procurement of Consultancy Firm for the Development of the Communication Plan and IEC/CEPA materials of the ESBenePeat Project

The Biodiversity Management Bureau intends to engage the services of a consulting firm for the development of a Communication Plan of the ASEAN-EU-GIZ SUPA Component 1 Country Project entitled: "Ensuring Sustainable Benefits from Peatland through Protection and Wise Use" (ESBenePeat)

**Description:** Consulting Service for the development of the

Communication Plan for peatland protection, conservation and sustainable management and IEC/CEPA materials of

the ESBenePeat Project

**Duration of Contract:** 3 months

**Approved Budget:** Php 672,000 inclusive of tax

#### I. Background and Rationale:

The Department of Environment and Natural Resources (DENR) — Biodiversity Management Bureau (BMB), in its capacity as the National Focal agency for the ASEAN Task Force on Peatlands (ATFP), with the support from GIZ Deutsche Gesellschaft für Internationale Zusammenarbeit (GIZ) GmbH, is implementing the ASEAN-EU-GIZ Sustainable Use of Peatlands and Haze Mitigation (SUPA) country project entitled "Ensuring Sustainable Benefits from Peatland through Protection and Wise Use (ESBenePeat)". The project is covered by a Grant Agreement by and between the DENR — BMB, and GIZ, with the implementation from 1 January 2022 to 31 October 2023. Its primary purpose is to ensure the provision of the ecological functions and services of the Philippines peatland through its protection and sustainable management.

The key measures to attain this goal are covered in the work packages of the project implementation plan, indicated as follows:

- · Work Package 1. Assessment, GIS, Mapping, and Database Establishment
- Work Package 2. Strengthening of Peatland Policy and Updating of the National Action Plan on Peatland.
- Work Package 3. Strengthening and enhancement of the capacity of relevant agencies and other concerned stakeholders on peatland management.
- · Work Package 4. Protection and Rehabilitation of Peatland.
- Work Package 5. Identification and Enhancement of Biodiversity Friendly-Practices for Peatland communities.

One of the output indicators under Work Package 4 of the ESBEnePeat project is the development of a communication plan and the development and production of IEC/CEPA materials.

#### II. Objectives and Scope of Work

The Project intends to engage the services of a consulting firm to (i) to develop a communication plan to increase and effectively disseminate knowledge on peatland protection, conservation and sustainable management, (ii)design and produce communication materials targeting different audiences; and (iii) to align and integrate the approved communication plan of the project into the overall communication plan of the Biodiversity Management Bureau.

The scope of work of this Terms of Reference is beyond the optimum in-house capability and current workload of the procuring entity and is consistent with the Government's policy not to compete with the private sector as integrated into Item 2 of Annex "B" of the 2016 Implementing Rules and Regulation of RA 9184.

#### III. Detailed Task

The consulting firm will work with the ESBenePeat Project Office and the OIC Chief of CAWED division of the Biodiversity Management Bureau, and will be responsible for the following tasks:

- 1. Develop, in close coordination with BMB, specifically with the Caves, Wetlands and Other Ecosystems Division (CAWED) and the Project Management Unit (PMU) staff of the ESBenePeat Project, a detailed communication plan on peatland protection, conservation and sustainable management to enhance the understanding and knowledge of the general public, key stakeholders in the government and private sector at the national and local levels and help achieve overall programme objectives. The communication plan must be aligned with the existing communication plan of the Biodiversity Management Bureau
- Develop a brand style guide that sets the standards for the design, composition and general look-and-feel of the Project's branding, from logo usage to color palette and typography, to ensure consistent brand identity in all knowledge products
- 3. Produce an informative 3-5-minute animated video on Philippine peatlands
- 4. Produce two (2) multi-fold brochures on Philippines peatlands:
  - a. brochure version of the animated video
  - b. informative brochure showcasing selected sites

The Consultancy Firm shall likewise be guided by the BMB brand guidelines, as provided under the BMB Technical Bulletin No. 2019-05.

#### IV. Duration

The services of the Consultancy Firm shall be engaged continuously for a period of three (3) months effective upon signing of the contract and Notice to Proceed.

#### V. Deliverables and Reporting Arrangements

This is an output-based engagement. The firm will not be required to report regularly or be present at the Project Office during the contract period but will be requested to attend meetings and report to the OIC Chief of CAWED regarding progress as necessary. The Consultancy Firm shall work closely with DENR-BMB specifically with CAWED and the Project Coordinator of the ESBenePeat Project for progress and updates on the consultancy assignment, the firm shall be expected to submit the following deliverables:

- 1. Outline of the communication plan and CEPA materials to be produced
- First drafts of the communication plan aligned with the BMB communication plan, the brand style guide complete with logo usage specifications, animated video, and brochures on Philippine peatlands
- 3. Final version of the communication plan in soft and hard copy, the brand style guide complete with logo usage specifications, and the animated video on Philippine peatlands

4. Print ready electronic copy of multi-fold brochures with recommended specifications for production/printing purposes
