PROCLAMATION NO. 557

DECLARING A CERTAIN PARCEL OF LAND OF THE PUBLIC DOMAIN LOCATED AT BARANGAY BINLOD, MUNICIPALITY OF ARGAO, PROVINCE OF CEBU FOR ECOTOURISM SITE PURPOSES

Upon recommendation of the Secretary of Environment and Natural Resources and pursuant to the power vested in me by the law, **I, GLORIA MACAPAGAL-ARROYO**, President of the Republic of the Philippines, do hereby declare a certain parcel of land of the public domain located at Barangay Binlod, Municipality of Argao, Province of Cebu, for Eco-Tourism Site, purposes under the Administration of the Municipality of Argao, Province of Cebu, subject to private rights, if any there be, which parcel of land is more particularly described as follows:

A PARCEL OF LAND, Lot 4960, Argao, Pls-1057-D, situated in the Barrio of Binlod (Sitio Candabong), Municipality of Argao, Province of Cebu, Island of Cebu. Bounded on the SE., along line 1-2 by Bohol Strait; on the SW., along line 2-3 by Lot No. 5990, Argao, Pls-1057-D; on the NW., along line 3-4 by National Road (20.00 meters wide); and on the NE., along line 4-1 by Lot No. 4961, Argao, Pls-1057-D Beginning at a point marked "1" on plan being N. 03 deg. 01' 2,649.09 meters from BLLM No. 1, Argao, Pls-1057-D.
