WHEREAS, The NCC was created through DENR Special Order (SO) No. 2008-687 and was amended through DENR SO No. 2016-654;

WHEREAS, the Director of the Biodiversity Management Bureau was designated as Chairperson;


WHEREAS, the Vice-chairperson shall be selected from the members and shall be given a two-year term;
