TERMS OF REFERENCE

<u>Technical Consultant to Develop Manual on Human-Wildlife Conflict Guidelines for certain</u>
<u>species (macaque, snakes, bats, wild pigs, and bird strike)</u>

The Department of Environment and Natural Resources- Biodiversity Management Bureau (DENR-BMB) intends to engage the services of a Technical Consultant to assist the BMB in the development of Manual on Human-Wildlife Conflict Guidelines for certain species which aims to provide a comprehensive guide to all DENR Regional and Field Offices in the management of incidents on human-wildlife conflict.

I. Background/Rationale:

Pursuant to Section 2 of the Wildlife Resources Conservation and Protection Act (R.A. 9147), the conservation and protection of wildlife species and their habitats to promote ecological balance and biological diversity, shall be of utmost consideration by the State. Consistent with this, the DENR has adhered to its mandate in the formulation and implementation of sound policies on the conservation and management of the country's wildlife resources. Policies being implemented by the DENR, through the Regional Offices and BMB, cover a broad range of activities which include management of human-wildlife conflict. A fundamental requirement to carry out this task is to recommend specific and elaborated procedures in the management of human-wildlife conflict.

The proposed manual which will be developed by the BMB with the assistance of the technical consultant is a compilation of specific protocols in managing human-wildlife conflict for certain species in conflict with humans namely: macaque, snakes, bats, wild pigs, and birds. The draft protocol shall be endorsed to the BMB Technical Review Committee to consider the document as a technical reference to be farmed out to the regions.

II. Objective and Scope of Work

Objective

To develop a comprehensive guide in the management of human-wildlife conflict for the following species: macaque, snakes, bats, wild pigs, and bird strike.

Scope of Work

The scope of work of this Terms of Reference is beyond the optimum in-house capability of the procuring entity and is consistent with the Government's policy not to compete with the private sector as integrated in Item 2 of Annex "B" of the 2016 Implementing Rules and Regulation of RA 9184. Quality-based evaluation will be used as criteria for choosing the consultant.

III. Job Description/ Duties and Responsibilities:

The technical consultant for the undertaking is expected to:

- Undertake literature review on various approaches and methods to avoid wildlife conflict, individual consultation with experts, and assess applicability in Philippine setting for possible adoption;
- Serve as facilitator during consultation workshop on the proposed draft manual as may be organized by the BMB;
- Draft specific protocol for each of the five species cited above based on literature review and consultation with experts;
- Submit the draft manual within the set deadline, for review and approval by BMB; and,
- Make the necessary revisions/edits on the draft manual based on the comments of BMB.

IV. Expected outputs/ deliverables for the engagement

• Printed and editable electronic copy of the final draft Manual on human-wildlife management approaches for the five species cited above.

V. Qualifications:

The contracted individual must have the following qualifications:

- At least a BS degree in Biology, Zoology, Animal Science, Wildlife Studies/Management or other related fields;
- With at least 2 years extensive field experience on wildlife research and conservation. Experience on human-wildlife conflict management is an advantage;
- Has excellent writing skills

The consultant is expected to deliver the outputs within six (6) months, after acceptance of Notice to Proceed (NTP).
