The Biodiversity Management Bureau (BMB), through its Coastal and Marine Division, seeks to procure the service of a Knowledge, Attitude, and Practices (KAP) Survey Data Analyst.

Background

The Biodiversity Management Bureau (BMB), through its Coastal and Marine Division (CMD), is implementing the Coastal and Marine Ecosystems Management Program (CMEMP), which aims to comprehensively manage, address, and effectively reduce the drivers and threats of degradation in coastal and marine ecosystems. As part of the program's monitoring and evaluation, and Behavior Change efforts, a nationwide Midterm Knowledge, Attitude, and Practices (KAP) Survey was conducted to assess the level of awareness and behavioral changes among stakeholders concerning biodiversity conservation and marine ecosystem protection.

To ensure that data collected from the survey is analyzed comprehensively and meaningfully, BMB seeks to procure the services of an experienced KAP Survey Data Analyst. The selected consultant will provide a thorough analysis of the survey results, correlating them with baseline data to evaluate the effectiveness of CMEMP interventions and recommend improvements.

Qualification

The candidate must have a degree in Anthropology, Sociology, Statistics, or any related field, with a minimum of three (3) years of professional experience in statistical analysis, Knowledge, Attitude, and Practices (KAP) surveys, data analysis, and conduct of social surveys. Preferably, this experience should be in the context of environmental and natural resource management. Additionally, the candidate must demonstrate proficiency in the following areas:

- Proficiency in statistical analysis methods, including both descriptive and inferential statistics, including experience with statistical software such as SPSS, R, or SAS;
- Strong analytical skills to interpret survey data accurately and derive meaningful insights;
- Understanding of the principles and methodologies underlying KAP surveys, including sampling strategies, and interpretation of results;
- Ability to communicate findings effectively through written reports, presentations, and data visualization tools. This includes the capacity to convey complex statistical concepts clearly and understandably to diverse audiences;

- Understanding of ethical guidelines and regulations governing survey research, data privacy, and confidentiality, particularly when working with sensitive or personal information; and
- Excellent ability to consolidate and synthesize substantive comments and views of multiple stakeholders in a balanced and concise manner.

Main objective of the assignment

This service includes a comprehensive analysis of data gathered from the nationwide Midterm KAP Survey conducted under the Coastal and Marine Ecosystems Management Program (CMEMP). The analyst shall also correlate these findings with data from Nationwide Baseline KAP Surveys.

Scope of Work

The KAP Survey Data Analyst shall report to the Director of the BMB. He/she shall work closely with the Coastal and Marine Division and the BMB Communication, Education, and Public Awareness (CEPA) Core Group. The consultant shall have the following duties and responsibilities:

1. Analyze KAP survey results conducted for all NIPAS Marine Protected Areas, encompassing 2023 Baseline KAP Surveys and all Midterm KAP Surveys;
2. Correlate the CMEMP Nationwide Baseline KAP Survey findings with the Midterm KAP Surveys;
3. Submit draft(s) of the KAP Survey Analysis report; and
4. Produce a Final comprehensive written report detailing the above analyses, complete with interpretation, graphical representations, and modeling for enhanced visualization.

Duty Station/Reporting

This engagement is output-based without the need for a daily or regular physical presence. However, the analyst may be required to report to BMB to personally meet with the CMD and BMB CEPA Core Group as the need arises. The Data Analyst is also expected to communicate and respond diligently through electronic communication channels.

Education

The Data Analyst shall have a degree in Statistics, Anthropology, Sociology, or any related field.

Experience

The Data Analyst should possess:

- A minimum of 3 years of professional experience in statistical analysis, particularly within governmental contexts, with a focus on Knowledge, Attitude, and Practices (KAP) Surveys;

- Engagement in at least 3 projects involving technical assistance, KAP survey implementation, comprehensive survey analysis and interpretation, and facilitation of stakeholder consultations;
- Knowledge/familiarity with any of the following survey analysis tools - SPSS, R, or SAS
- Participation in a minimum of 3 training sessions related to the utilization of KAP survey data for biodiversity conservation and protection initiatives.

The contract price is all-inclusive, fixed, and output-based regardless of any extension of the herein specified duration. The Contractor shall receive payment in the amount of One-Hundred Sixty Five Thousand Pesos (P165,000.00), inclusive of taxes based on the following tranches and deliverables:

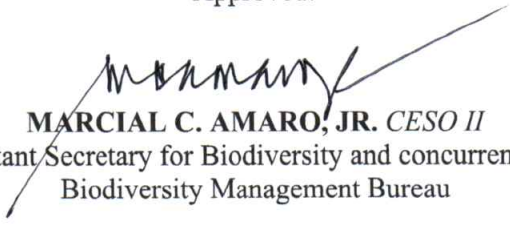
